PRODUCTIVITY WORKSHOP: 6S IMPLEMENTATION

COURSE OVERVIEW

All companies are facing increasing competition, rising costs, and an increasingly demanding customer base. It is essential that an effective productivity and quality improvement strategy be in place for the company to succeed in the market. Although very basic, the 6S systematic housekeeping system will help build a solid foundation for other improvement activities. Proper implementation of 6S also helps transform the workforce and build a culture of responsibility and improvement. Unfortunately, many Malaysian businesses pay only a cursory attention to systematic housekeeping, resulting in a waste of scarce resources. This training adopts a hand-on workshop approach so that a certain level of skill transfer happens during the training. An implementation kit (Red Tag, Checklist, and Master Plan) is provided so that trainees can jump-start their implementation process.
